

## Directions

**From Interstate 95:** In Ormond Beach exit onto state road 40 west towards Ocala. Turn right on state road 19. Proceed north on 19 approximately 26 miles to the Barge Canal bridge. Turn left just after the bridge onto County Road 310. Go 1 mile to a paved road and turn right. The Rodman Plantation house will be on your right. 298 CR 310, Palatka, FL 32177. Look for event signs.

**From Interstate 10:** From I-10 West take exit 361 and merge onto FL-15S/FL-228 W/US-17 S. Turn onto FL-19S and travel approximately 50 miles to the intersection with CR 310. Turn right onto CR 310 and follow above directions.

**From Interstate 75:** In Ocala exit onto state road 40 east toward Ormond Beach. Turn left on state road 19 and follow the above directions.

### HUNTING DOG STAKE

The Timucuan Weimaraner Club of Florida is pleased to announce that the non-regular Hunting Dog Stake will be offered Saturday February 3, 2018 starting no sooner than 10am and beginning at the discretion of the HT Committee. Non-regular walking class open to all pointing breeds. This stake is designed to focus on dogs that have completed their JH title and are working towards the SH title. Each brace is 15 minutes. Dogs may be collared while on point and may run with a check cord. Training Collars used to control and train dogs including but not limited to collars with prongs, electronic collars used with transmitters, muzzles and head collars may not be used.

**Eligibility:** Any dog that is eligible to compete in licensed AKC pointing breed field trials or hunt tests is eligible to run in the Hunting Dog Stakes. Placements will be made at the end of each day and ribbons will be awarded for Places 1 thru 4.

A dog may run, but is not eligible for placements in a stake if it:

1. Has completed a Senior Hunter or Master Hunter title.
2. Has placed 1<sup>st</sup> in a broke dog stake.

Other breeds, or Weimaraners, not owned by TWCF members, are eligible for placement at individual stakes only. Only Weimaraners owned by TWCF members are eligible for cumulative placements and the Hunting Dog of the Year Traveling Trophy. Bitches in season may run at the end of the day\*. **Judging:** Each dog is judged on a dog's actual performance and its potential as a worthy hunting companion. **Entries:** Advance entries are \$23 (cash/check), \$26 PayPal via our website (weimtime.net) and must be received before Wednesday January 31, 2018. Entries may be made at the event for \$30 and if there is time to run. Precedence in the running order will be given to advance entries.
